- Groups requesting EXCLUSIVE USE of all facilities will be charged for a full capacity camp; otherwise charges will be only for cabins reserved and confirmed.
- Minimum charges for facilities used are based on rated capacities.
- County Youth – At least 75% of group users shall be Clallam County residents.
- County – At least 75% of users shall be Clallam County residents.
- Cots – May be set up to extend the capacity (when allowed by Park Manager).
- Use of kitchen/dining hall/lodge included when at least four cabins excluding Beach Cabin are rented.
- Firewood fee of \$15.00 per day, unless users bring and burn their own wood.
- Extra charge of \$3.00 per cabin used during winter months (October 1st through April 30th).
- One policy manual per organization. Additional copies available for \$2.00 each.
- Use of WoHeLo Lodge (Log Cabin) requires day use fee – see below.
- NOTE: Applicable sales and lodging taxes will be added to all fees. Currently this is 10.4% for overnight fees, 8.4% for all other fees, but is subject to change without notice.

Penalty for late payment will be charged at 1% per month unless other arrangements are made in advance.</p>	<p>Small Groups: (1 – 31 campers) If the camping agency, organization, or family unit cancels its reservations, the deposit fee will be forfeited.</p> <p>Large Groups: (32 – 102 campers) If the camping agency, organization or family unit cancels its reservations, the deposit is not refundable unless another group of the same size can be scheduled for the same period of time.</p>
